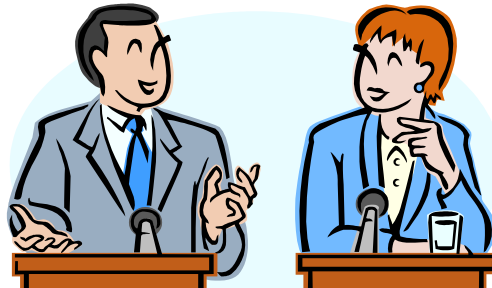

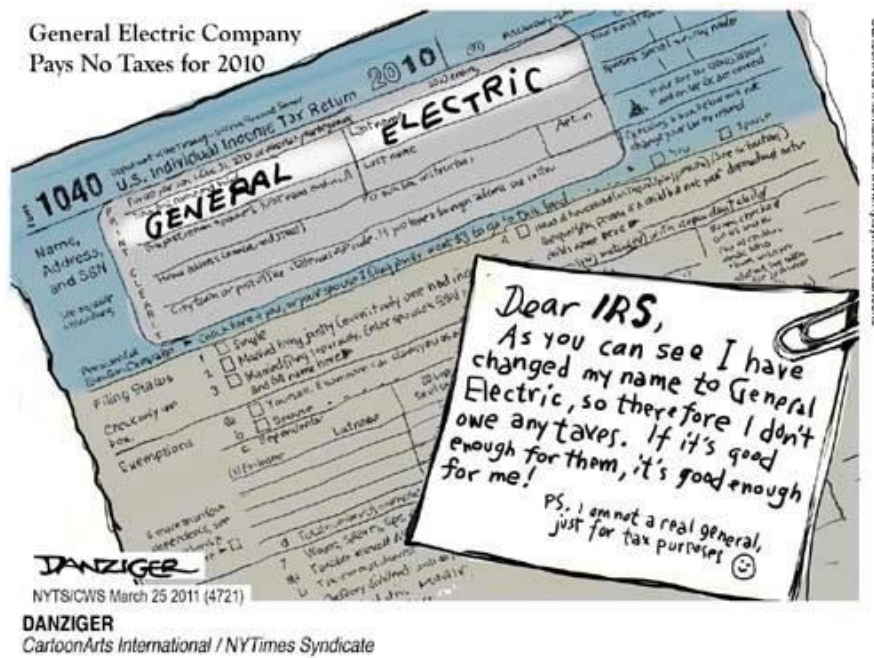

STUDY POSITIONS:

The League of Women Voters of Darke County has three ongoing study positions. They are concerning Land Use, Health and Education. A vote to continue each of these positions will be taken at our upcoming Annual Meeting.

LAND USE STUDY POSITION:

1. The Darke County LWV favors a countywide system of land use planning compatible with the resolutions available to all political subdivisions.
2. The Darke County LWV favors regional planning.
3. The Darke County LWV favors land use policy that would encourage preservation of prime farmland.

HEALTH STUDY POSITION:

1. The Darke County LWV believes that a public health commissioner candidate should possess administrative and leadership ability, have knowledge of public health issues and previous experience.
2. The Darke County LWV supports the right of every person to have access to quality health care.

EDUCATION STUDY POSITION:

1. The Darke County LWV favors the income tax option as a supplemental method of funding local school districts.
2. The Darke County LWV membership is not satisfied unless superior standards are being met for educational programs and services.
3. The Darke County LWV supports local funding for superior educational programs and services.
4. The Darke County LWV supports evaluation methods providing more time for conferences, more time and space to write narratives and grading systems reflecting student effort as an alternative to letter grades for grades one and two.

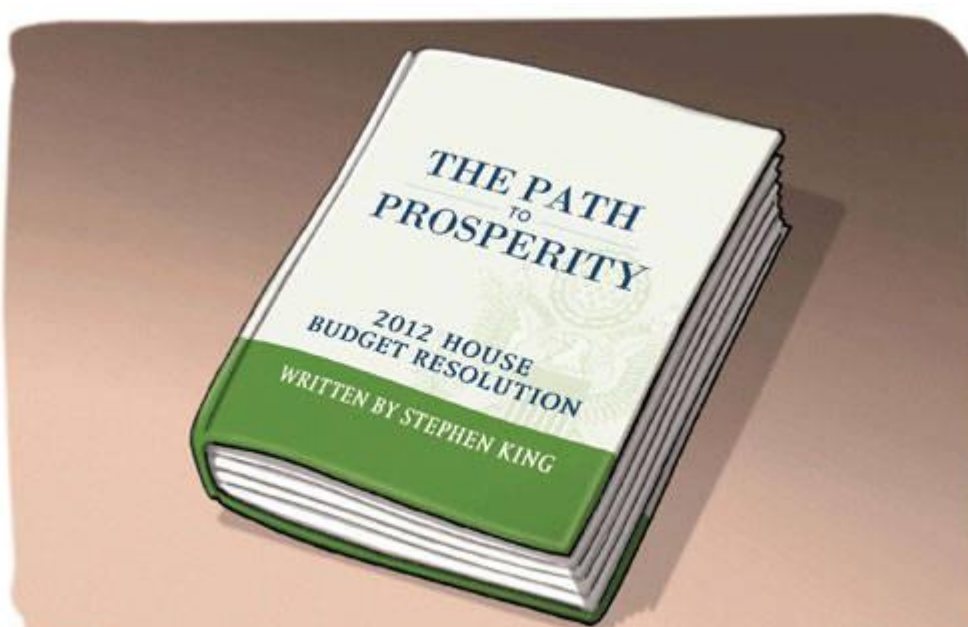
